I am greatly concerned at reports that the Henry Tax Review is considering recommendations to remove or change the dividend imputation scheme. The current scheme helps to support my desire to invest in Australian companies. I believe a removal or change to the scheme is an unfair, unnecessary and retrograde step. I am greatly concerned that it will negatively impact the value of Australian companies I'm invested in who provide me dividend income that include franking credits and am writing to highlight my concerns for Australian investors who rely on dividend income, especially retirees.

I regard the issue as serious enough to affect my voting decision at the next Federal election.
