We are greatly concerned at reports that the Henry Tax Review is considering recommendations to remove or change the dividend imputation scheme. We are greatly concerned that it will negatively impact the value of Australian companies we are invested in who provide us dividend income that include franking credits.

We are writing to highlight our concern for Australian investors who rely on dividend income, especially retirees.
