I am greatly concerned at reports that the Henry Tax Review is considering recommendations to remove or change the dividend imputation scheme. The current scheme helps to support my desire to invest in Australian companies. I believe a removal or change to the scheme would be an unfair, unnecessary and retrograde step. I am greatly concerned that it will negatively impact the value of Australian companies in which I have invested. These provide me with dividend income which includes franking credits.

I am writing to highlight my concern for Australian investors who rely on dividend income, especially retirees.
